Song or Aloysius Pieris have gone too far in their insistence that Asia is defined by its poverty. However, defining Asianness has been a significant problem in Asian theology, with many theologians unknowingly buying into and reinforcing an occident-orient binary that not only essentialized the West but also essentialized themselves. Generalizing the experience of Asian women as oppressed or poor is to universalize and homogenize the diverse experiences of actual Asian women; it ignores the actual experiences, thoughts, concerns, and values of those on the ground. Many Asian theologians have thus reinforced orientalist stereotypes in this way, attempting to speak for all but actually speaking for no one. Defining Asian in Asian theology is by no means an easy task, part of its story has been the struggle to properly articulate its identity in a complex and changing world. Despite this, many today are still hopeful in the possibility of Asian theology; books continue to be written that provide new visions for Asian theology, teachers and students wait for textbooks and other resources to help them deal with theological issues and read the Bible better in their own contexts. If theology is to bridge the gap between God's unchanging nature and humanity's changing cultural context, then it must be rooted in a specific location to function effectively. In other words, successful church growth in a different culture often requires "indigenization" - losing its foreignness in that culture. However, there are several challenges associated with this approach, particularly from an Asian perspective. Elwood notes that Asian theology should have a universal character for the ecumenical church, rather than being confined to specific ethnic groups. However, it is unclear what would prevent this "ghettoization" from occurring, given the diverse experiences and perspectives within Asia. Atheyal emphasizes the importance of indigenous theology in promoting unity and cooperation among Asian Christians. He suggests that an "Asian Creed" could serve as a unifying force, transcending denominational boundaries. Nevertheless, the complexity of Asian cultures and the prevalence of disunity within some churches, such as those in China and the Philippines, raise questions about the feasibility of this approach. The author acknowledges the value of localized theology but expresses doubts about the grand scheme of a unified Asian theology. They believe that cultural uniqueness should be respected and honored, rather than ignored. Some commonalities do exist across Asian cultures, such as the emphasis on honor and shame over forgiveness and guilt or power and fear. However, these shared aspects must be balanced with the need to acknowledge regional differences and cultural contexts. Ultimately, theology seeks to link God's unchanging revelation to changing cultures and contexts.
